# April Combined Unit Meeting: "Perspectives on the AISD Bond Election"



On the upcoming May 11 ballot, Austin voters will be asked to consider an Austin Independent School District bond package totaling \$892,245,000. Early voting for the election is right around the corner--April 29 to May 7. Make an informed decision at the ballot box by coming to hear our two speakers. Open to the public.

### Monday, April 8, 10:15 am Howson Library, 2500 Exposition Blvd., near Windsor

We will kick off the program with an overview of what is in the bond package, presented by **Yesenia Garcia**, Public Relations Coordinator for the Office of Facilities for AISD. She will be followed by **Casie Wenmohs**, Legislative Director of the Austin City Council of PTAs who has a thorough knowledge of AISD financial issues and will provide different perspectives on the bond proposal.



The AISD approved the bond program on Feb. 25, asking for authorization to issue tax bonds to finance improvements that are grouped into four propositions:

- **Proposition 1**, health, environment, equipment, and technology;
- **Proposition 2**, safety and security, relief from overcrowded schools, new schools, and new construction;
- **Proposition 3**, academic and building infrastructure renovations to safeguard investments in districts campuses; and
- **Proposition 4**, academic initiatives, fine arts, and athletics.

Redistricting Commission Update



The Applicant Review Panel that was chosen at a drawing (3 women were randomly selected from 7 women and 6 men) is functioning now, looking at over 500 applications from citizens across Austin. They have open-to-the-public meetings that are posted on the Auditor's 10-One web site. So far, most of their meetings have been at 6:00 on Fridays.

On the 10-One site, you can look at all the candidates who made application and comment on any of them to the panel (in writing or in person). All the applicants who met the basic qualifications and are being considered by the Applicant Review Panel (all independent auditors) have their applications available on the site for anyone to look over.

The Panel has until the middle of May to choose 60 of the most qualified

## **Healthcare Study Group Reports**

#### **Medicaid Expansion:**

After retiring as Senior Economist in the Texas Comptroller's Office, one committee member, **Tamara Plaut**, joined Billy Hamilton Consulting and helped author a publication entitled: *Smart, Affordable and Fair: Why Texas Should Extend Medicaid Coverage to Low-Income Adults.* The report analyzes state and local impacts of extending Medicaid under the Affordable Care Act on a county-by-county level. The full report can be downloaded from the Texas Impact website: <a href="www.texasimpact.org">www.texasimpact.org</a> or from the Methodist Healthcare Ministries of South Texas website: <a href="www.mhm.org">www.mhm.org</a>.

In 2014-15, the federal government would provide \$9.1 billion to TX under Medicaid Expansion. It would cost TX \$1.2 billion. Whether TX will expand Medicaid is questionable although many Democrats and a few Republicans are now in favor of it. Even if the Legislature passed a bill, the governor could veto it and it is doubtful that the veto could be overridden. 24% or 6 million Texans are uninsured. It costs localities

# 10-Digit Dialing for Austin Area

Effective June 1, 2013, 10-digit dialing - the appropriate area code (512 or 737) plus the seven digit telephone number will be necessary for local calls to be completed. Calling rates will not be affected by this change. Calls will not go through if you just dial seven numbers.

\$4.4 billion to cover unreimbursed trips to the emergency room for uninsured individuals.

Under Medicaid expansion, the number of uninsured persons would drop by 25% and they would be able to access care before they developed more complicated (and costly) medical problems. Medicaid expansion also would help the economy by taking the burden of indigent care off local governments and hospital districts, possibly slowing the increase in property taxes. Billy Hamilton estimated that the influx of federal funds would generate increased economic activity and add an estimated 231,000 jobs statewide by 2016.

#### Affordable Care Act and Austin:

The new health insurance system under the Affordable Care Act is going live on January 1, 2014 and this study group may want to investigate how it's getting implemented in Austin. The free-ranging discussion at our March meeting came up with these possible tasks:

- Get a snapshot of where our community health care systems are in the implementation process (mental health as well as physical health)
- What exactly is expected to change in terms of care
- Determine what safety net is in place to take care of people that don't qualify for the new insurance system
- Find out what is being done to enroll people in the system, how is it being publicized
- What does it mean for the medical school
- How might we help with the enrollment process
- What is the role of public health once ACA is implemented

The Court wants to create task force to identify ways economic development and procurement policies can improve wages and working conditions in construction. The burn ban, which is usually extended week by week, was extended for 4 weeks due to the expected continuation of dry conditions.

In a possible sign of improving economic conditions, the Transportation and Natural Resources department submitted an unusually lengthy list of building and development activity in the

county. Included was a request for approval of a 228-unit apartment building in the Bee Cave ETJ (Extraterritorial Jurisdiction) on RM 620. An area resident who objects to the plans for the new development presented aerial photos and raised several questions. Commissioners agreed that there may be aspects of the complex that need to be reviewed, and they postponed action until after a hearing by the City of Bee Cave in April.
