VOTER CHECKLIST

Here is everything you need to know before you go to vote. Complete all of the steps below, and you'll be ready and prepared to go to the polls.

- ☐ Confirm voter registration: Registered voters will have received a voter registration certificate (see page 27 for an example). While this document is not needed to vote, it contains helpful information about your districts, precinct, and more. If you do bring it to the polls, a poll worker can use it to confirm your eligibility if there's any problem. Receiving the certificate is confirmation that you are eligible to vote. If you aren't sure you are registered, you can check online at VoteTravis.com or www.wilcotx .gov/elections. Students, see page 2 for more information. As of this printing, the deadline for new registrations for this election will have passed, but please register now for future elections.
- ☐ Update your voter registration name or address: To vote, you must update your registration every time you move or change your name. If you have not updated your voter registration information, you may be required to vote provisionally. That means your vote will not be tallied until the issue surrounding voter information has been resolved. Be sure to update your voter registration BE-FORE YOU COME TO THE POLLS:
- > You may correct your voter registration information on the back of the voter registration certificate and mail it to your local voter registrar.

☐ Bring Photo ID—You must use one of seven forms of ID to vote:

- > Texas driver license
- Texas Election Identification Certificate (EIC)
- > Texas identification card issued by DPS
- > Texas handgun license issued by DPS
- ➤ US military identification card with visible photograph
- ➤ US citizenship certificate with visible photograph
- ➤ US passport (book or card)

If you do not have one of the above photo IDs, as a registered voter you can still vote. You will be required to sign a Reasonable Impediment Declaration form and present a copy or original of one of the following documents:

- > Texas voter registration certificate
- Certified birth certificate
- ➤ Current utility bill
- > Bank statement
- ➤ Government check
- > Pavcheck
- ➤ Any other government document such as an out-of-state driver license or an expired Texas driver license
- ☐ Check ID expiration date: You can still vote with an expired photo ID. IDs may be expired up to four years. For voters age 70 or older, there is **NO** limit on ID expiration.
- ☐ Know your voting rights
- ➤ If you are still in line when the polls close, stay in line. You will be able to vote past poll closure as long as you stay in line.

- You may ask for another ballot if you need to make changes to your ballot after printing it.
- ➤ If voting machines are down, you may ask for a paper ballot.
- ➤ If you run into issues on Election Day, call an Election Protection Hotline.

- ☐ Vote safely: The League of Women Voters encourages you to "Be a Safe Texas Voter!"
- ➤ **Vote at home by mail:** You must be 65 years or older, have a disability, be out of the county during early voting and Election Day, or be an eligible voter in jail. See **below** for more information on how to apply.
- ➤ **Vote early:** The early voting period is February 20 March 1. Take advantage of this to avoid busy polling places on Election Day. During early voting and especially on Election Day, vote during non-peak hours, such as mid-morning or mid-afternoon.
- ➤ **Vote with a mask:** That includes polling places anytime you go to vote. We encourage everyone to wear a mask at polling locations so everyone can vote safely.
- ➤ Vote six feet apart: Distance yourself from other voters and poll workers by at least six feet. It may seem that the lines are a bit longer, but that only means everyone is working to stay safe.

HOW TO VOTE BY MAIL

A registered voter may vote by mail (VBM) if they:

- ➤ are 65 years of age or older (eligible for mail-in ballots for an entire calendar year).
- are sick or disabled (eligible for mail-in ballots for an entire calendar year).
- will be absent from the county during the entire early voting period and Election Day, AND provide an out-ofcounty address where the ballot can be mailed, AND include dates they can receive mail at the out-of-county address (eligible only for one election at a time). Voters who are absent from the county because they are active duty military or because they reside overseas should complete a Federal Post Card Application. Information and forms are available from county and state offices.
- ➤ are confined in jail, but otherwise eligible to vote (eligible only for one election at a time).
- are expecting to give birth within three weeks before or after Election Day.

The procedure:

 Request the application, which is available for download from the county elections or secretary of state websites, or by calling or emailing the appropriate office. The appli-

- cation is known as an ABBM (application for a ballot by mail). https://bit.ly/2YL0Gi3
- 2. IMPORTANT—The application MUST be completed and received by the early voting clerk in the Travis or Williamson County Elections Division office by February 23, 2024. NOTE: If you submit an ABBM by fax or email, it must also be submitted by mail and received in the appropriate office within four business days of your electronic submission.
- 3. Once received and completed, the mail-in ballot MUST be mailed and postmarked by 7:00 p.m. on Election Day and received by 5:00 p.m. on the 1st mail day after Election Day, or if civilians abroad the 5th day after Election Day, or if Military voters the 6th day after Election Day. A VBM tracker and "Cure" process is available at VoteTexas.gov.
- ➤ Track your VBM application and VBM ballot throughout the election process.
- ➤ Provide contact information on your VBM application so the county may contact you if you need to fix an error with your application or ballot.

STUDENT VOTERS

Students may use either their parents' address or their college address for voter registration, whichever they consider to be their permanent address. Students cannot be registered in both places. Those who will be away from their permanent address on Election Day and during early voting may request a ballot by mail from their county clerk's office. Student voters should also know that college or university student photo IDs are not accepted at the polls. Be aware of the general ID requirements.

VOTING SYSTEM

Both Travis and Williamson Counties are now using an ExpressVote Ballot Marking Device (BMD), which uses touch-screen technology but produces a paper ballot for tabulation. It is modern, secure, and allows you to verify your selections before casting your vote.

Steps to Vote

 VOTE: At check-in you will receive a blank ballot. Insert this ballot into any ExpressVote BMD. Follow instructions on the screen to make your selections. Poll workers will be available if you need assistance.



REVIEW: When prompted, print your ballot. Carefully review all the selections printed on the card to be sure it accurately reflects your choices.



 SCAN: You MUST then scan your ballot into the DS200 scanner to cast your vote. Do NOT leave the polling location with your ballot.

We invite every candidate in competition for office to provide information. We list the names of unopposed candidates but do not send them questionnaires. Political affiliations in partisan races are abbreviated as follows: (D) Democratic Party, (R) Republican Party, (L) Libertarian Party, (G) Green Party, (I) Independent.

This Voters Guide and other educational League materials are funded by member and supporter donations. Donations may be made at **LWVAustin.org**. Donations enable us to print and distribute more guides and to offer translations into Spanish, Chinese, and Vietnamese. Answers from candidates who didn't respond by the print deadline may be available online.

HOW THE LEAGUE GATHERS CANDIDATE INFORMATION

To compile the Voters Guide information, the League of Women Voters Austin Area sends questions to all candidates in major contested races. League members verify accurate contact information provided by various election entities and the Texas Secretary of State. The League formulates all questions through a rigorous questions committee. Candidate replies are printed without editing or verification of content. Due to space restrictions, candidates are given strict character limits. The form into which they enter answers prohibits them from violating the limit. If a response has been cut off due to this constraint, the response has [.] inserted at the end. Candidates are also asked to avoid negative references to their opponents. We reserve the right to redact portions of responses that do not meet our guidelines. Those appearing without a photo failed to submit one. Candidates must submit answers by the deadline provided in order to be included in the printed version. Answers on **VOTE411.org** may be updated after the print deadline.

CANDIDATE RESPONSES

The League of Women Voters Austin Area reviews all candidate responses carefully for adherence to our guidelines. The League reserves the right to redact portions of a candidate's

response, but avoids doing so as much as possible. Candidate replies are printed without editing or verification of content. The League takes First Amendment rights seriously and believes that the public has a right to know what the candidates think and what they stand for, even if it may be considered offensive. Each candidate is personally and solely responsible for the content of their response.

HOW DOES THE LEAGUE HANDLE BALLOT MEASURES?

For each ballot measure (such as bonds, charter amendments, or other propositions), the League researches and analyzes the topic and provides information to help explain the background and effects of the proposed change. We do not always include pros and cons, and instead focus on explaining potential effects of the measure's passing. If we do offer pros and cons, we make sure they are balanced and include both points of view. The following information is typically included:

- > Background: How did this get on the ballot and what group brought it forward?
- ➤ Ballot language explainer: What does the ballot language
- > Potential effects: What possible effects will this ballot measure have on our area?

I have also championed modernizing the Voting Rights Act to protect the right to vote.

Immigration: My mother was raised in Brownsville and I

often spent summers visiting my grandmother in the Rio Grande Valley. Our current immigration system is broken and I support comprehensive reform that includes securing our borders, protecting Dreamers, and providing a pathway to earned citizenship for those who are working hard and obeying the law. I will work with both parties to get this done.

International Relations: I have served on the Foreign Affairs Committee, and I believe a strong national defense is critical to protecting America and our interests around the world. We must defend democracy and democratic values. It's why I support Ukraine and its effort to defend its democracy against Russian aggression. I also believe we must deter Chinese aggression and stand by our partner Taiwan.

Climate Change: We need action to address the climate cri-

official has a duty to uphold their oath, but they also have the opportunity to lead by example. Senators should work for constituents rather than finding ways to trend on social media.

Immigration: Stop using people as props and fix the problem. Rhetoric around mass deportations hurts any reasonable and bipartisan effort to achieve legislation. This must include a pathway to citizenship for those here and protections for DREAMers and their families. More can be done to protect farm workers and hold individuals accountable for taking advantage of immigrant workers.

International Relations: We have a moral obligation to protect freedom and promote peace around the world. That does not mean forgetting about problems at home, however. We should champion democracy globally, but do it through diplomacy, international cooperation, and fair economic policies. We can promote a world that respects democratic values while safeguarding our economic interests and national security.

Climate Change: We should be concerned about the global warming of our planet and its impact on water, farming and employment. When we talk about climate, we need to talk about how to protect, expand jobs. Democrats cannot ignore the impact on jobs in Texas when talking about climate change. That's an opportunity to grow solar and wind power manufacturing jobs and ultimately obtain a net-zero emissions economy.

I would seek several changes, including campaign finance reform that provides greater transparency to voters, and a ban on gerrymandering for congressional districts. Immigration: We must: 1) provide a pathway to normalcy for undocumented workers; 2) provide DREAMers immediate citizenship; 3) create a new work program for arriving immigrants that meets the needs of our economy; 4) fix and streamline dysfunctional visa program; and 5) end human trafficking and stop drug cartels.

Qualifications: The Senate must be able to communicate effectively with a variety of people, including colleagues, staff, constituents, and the media. I am most capable of working well under pressure.

Democracy: American democracy is at a dangerous inflection point. The moment requires a step-change in strategy and support. Without such momentum, the country faces a democratic setback. Many Americans view this moment with concern with worthy measure. America's system is creaky, but the world's oldest democracy has strong institutions and will pull through.

Immigration: Since the end of the Cold War, most democratic failure globally has been caused by elected governments using legal methods, such technical rule changes, to derail democracy. Their destructions of their own democracies have been supported by pluralities or majorities of their citizenries, whose polarization leads them to back policies that harm democracy to ensure their side prevails.

International Relations: Many of the laws that form in-

stitutional guardrails were written poorly in the aftermath of the Civil War, with loopholes that are easily challenged given a lack of precedent. Moreover, the country's age means that much of what are presumed to be laws and institutions are, in fact, simply norms. These norms are eroding quickly. Climate Change: In America, many states have been flooded with laws to alter voting. The worst of these maneuvers have occurred in a dozen states that have passed laws transferring power to more partisan electoral bodies and/or criminalizing their election administrations. These antidemocratic legal moves cannot be overcome by turnout. In turn, effecting all climate change policy measures.

Qualifications: Steve is a retired Navy Captain. He has a Master's Degree in Congressional Studies and a law degree. He was appointed by Presidents Clinton and GW Bush to the National Nuclear

Threat Assessment team.

Democracy: It is important that US Senators hold themselves to higher standard of accountability. Accuracy and transparency are paramount. A key role of Senators is their oversight function. Emissions: Methane has a massive impact on climate change when flare stacks fail to maintain ignition. Flaring is a waste of resources not only from a monetary benefit for the State of Texas but for the royalty owners and society's benefit for use. Flaring should be only as needed in emergency exemption. RRC is fully responsible for reducing all flaring from the oilfields.

Seismic Activity: RRC has failed to monitor and manage toxic radioactive isotopy laden produced water disposal everywhere in Texas. We must determine which SWD wells must be highly limited due to extreme risk and implement strict limits on volumes per section to let pressures decline. We must properly plug old wells nearby SWDs to prevent zombie wells. We must invest in fresh water recycling technologies.

Ethics: By being fully transparent with campaign finance documents and recusing oneself if rulings or actions present a perceived conflict of interest. Commissioners should also fully disclose in detail any royalties or working interest in companies or wells or projects that are under the jurisdiction of the RRC. The key is transparency and disclosure.

Emissions: Flaring releases methane (natural gas) and other hazardous air pollutants and contributes to ground-level ozone. RRC needs to update Rule 32 to define when a flaring permit should be granted, remove flaring applications from the consent agenda, and hold companies accountable for the environmental damage they are doing to all of us. They have only denied 44 out of >8000 permits since May '21.

Seismic Activity: The limits the RRC are putting on the injection wells are not working. We need to further limit the number of injection wells and the locations by not injecting disposal water near natural fault lines. Additionally, we need to hold the companies accountable for treating the waste water so it is not toxic and can be reused elsewhere.

Ethics: There is a difference between receiving income from working in an industry and making windfall profits from corporate investments with the companies you are regulating, having your actions directly increase your profits. Many agencies prohibit investments in companies that are affected by agency actions and Texas needs to implement the same rules.

Ethics: Sadly, they aren't as yet. I have argued this issue to the U.S. Sup. Ct. and have repeatedly proposed reforms that have been approved by the Supreme Court and exist elsewhere. Judges (1) should not sit in cases where they've received large contribution from either side (by direct or indirect means), (2) should not be contacting parties for \$, and disclosure should be direct and immediate.

Separation of Powers: Courts are passive players with the vital role of assuring fidelity to the operative constitutional assurances that constrain all three branches. Courts must arrogating power onto themselves—without a clear textual mandate—or allowing other branches to encroach on each other. They are not empowered to impose their policy preferences on legislative choices assigned to the legislature.

Equity: I received the State bar's highest award for pro bono service in securing access to the pro bono or low cost representation through representation of the state before the U.S. Supreme Court. In criminal cases indigent parties are assured counsel. Defendants in death penalty cases should not be receiving lawyers who have been sanctioned or suspended, as has happened in recent years.

Background: I come to this race with a background in grassroots field organizing. I've chaired Democratic precincts in six of the last eleven years, and was trained by Battleground Texas as a Neighbor-

hood Team Leader, organizing a full grassroots field for the Wendy Davis campaign. I have BBA and MS degrees in Finance from Texas A&M.

My professional career was in banking and later, wireless telecommunications, and finally, as a self-employed fitness trainer. Though raised Republican, I came to disagree with the party's direction. I've been a Democrat now for a quarter-century.

Top Issues: My number one issue is DEMOCRACY. While there are so many pressing imperatives today – climate change, voter suppression, underfunded public education, children slaughtered by guns of war, a legislature practicing medicine without a license - NOT ONE of these demanding issues may be rectified without democracy. Right now, Austin literally usurps tax revenues collected by school districts and directs them toward thoroughly unrelated uses. High property taxes are increasingly burdensome, and yet our schools are underfunded. How does this paradox exist? Because the Republican majority imposes a dishonest tax, making school districts "do the dirty work" of raising them while Austin gets to scheme over how the loot gets spent. There are other pressing matters, to be sure. Banning books, privatizing it all for billionaire enrichment. But that discussion exceeds 100 words.

Voter Concerns: Voters in HD19 are concerned about many of the same things as other Texans. They're concerned about water scarcity - a consequence of climate change. I've talked about education and preserving democracy. They're worried sick, dropping off their daughters and sons, that it may be their last goodbye. They suspect our best years may be behind us and our future is a diminished one. But this need not come to pass. Just one institution stands between us and the bright future we all know we can build, and that's the Republican Party. Return Democrats to power, and we'll restore that future.


