VOTER CHECKLIST

Here is everything you need to know before you go to vote. Complete all of the steps below, and you'll be ready and prepared to go to the polls.

☐ Confirm voter registration: Registered voters will have received a voter registration certificate (see page 19 for an example). While this document is not needed to vote, it contains helpful information about your districts, precinct, and more. If you do bring it to the polls, a poll worker can use it to confirm your eligibility if there's any problem. Receiving the certificate is confirmation that you are eligible to vote. If you aren't sure you are registered, you can check online at VoteTravis.com or apps.Wilco .org/elections/. Students, see page 2 for more information. As of this printing, the deadline for new registrations for this election will have passed, but please register now for future elections.

☐ Update your voter registration name or address: To vote, you must update your registration every time you move or change your name. If you have not updated your voter registration information, you may be required to vote provisionally. That means your vote will not be tallied until the issue surrounding voter information has been resolved. Be sure to update your voter registration BEFORE YOU COME TO THE POLLS:

> You may correct your voter registration information on the back of the voter registration certificate and mail it to your local voter registrar.

☐ Vote Early or on Election Day

WHERE: Residents of Travis and Williamson Counties can vote at ANY polling place in their county. Locations and wait times are available at the following county voter information websites.

Travis County: VoteTravis.com Williamson County: Wilco.org/elections

WHEN: Early voting is available April 24-May 2; times and locations may vary. On Election Day (May 6), polls are open from 7:00 a.m. to 7:00 p.m.

☐ Bring Photo ID—You must use one of seven forms of ID to vote:

- Texas driver license
- ➤ Texas Election Identification Certificate (EIC)
- Texas identification card issued by DPS
- Texas handgun license issued by DPS
- ➤ US military identification card with visible photograph
- ➤ US citizenship certificate with visible photograph
- US passport (book or card)

If you do not have one of the above photo IDs, as a registered voter you can still vote. You will be required to sign a Reasonable

Impediment Declaration form and present a copy or original of one of the following documents:

- ➤ Texas voter registration certificate
- Certified birth certificate
- Current utility bill
- Bank statement
- Government check
- Paycheck
- > Any other government document such as an out-of-state driver license or an expired Texas driver license

☐ Check ID expiration date: You can still vote with an expired photo ID. IDs may be expired up to four years. For voters age 70 or older, there is **NO** limit on ID expiration.

☐ Know your voting rights

- ➤ If you are still in line at 7:00 p.m., stay in line. You will be able to vote past 7:00 p.m. as long as you stay in line.
- > You may ask for another ballot if you need to make changes to your ballot after printing it.
- ➤ If voting machines are down, you may ask for a paper ballot.
- ➤ If you run into issues on Election Day, call an Election Protection Hotline.

- ☐ Vote safely: The League of Women Voters encourages you to "Be a Safe Texas Voter!"
- ➤ Vote at home by mail: You must be 65 years or older, have a disability, be out of the county during early voting and Election Day, or be an eligible voter in jail. See below for more information on how to apply.
- ➤ **Vote early:** The early voting period is April 24–May 2. Take advantage of this to avoid busy polling places on Election Day. During early voting and especially on Election Day, vote during non-peak hours, such as mid-morning or mid-afternoon.
- **Vote with a mask:** That includes polling places anytime you go to vote. We encourage everyone to wear a mask at polling locations so everyone can vote safely.
- ➤ Vote six feet apart: Distance yourself from other voters and poll workers by at least six feet. It may seem that the lines are a bit longer, but that only means everyone is working to stay safe.

HOW TO VOTE BY MAIL

A registered voter may vote by mail (VBM) if they:

- > are 65 years of age or older (eligible for mail-in ballots for an entire calendar year).
- are sick or disabled (eligible for mail-in ballots for an entire calendar year).

- > will be absent from the county during the entire early voting period and Election Day, AND provide an out-of-county address where the ballot can be mailed, AND include dates they can receive mail at the out-of-county address (eligible only for one election at a time). Voters who are absent from the county because they are active duty military or because they reside overseas should complete a Federal Post Card Application. Information and forms are available from county and state offices.
- > are confined in jail, but otherwise eligible to vote (eligible only for one election at a time).
- > are expecting to give birth within three weeks before or after Election Day.

The procedure:

- 1. Request the application, which is available for download from the county elections or secretary of state websites, or by calling or emailing the appropriate office. The application is known as an ABBM (application for a ballot by mail). https://bit.ly/2YL0Gi3
- 2. **IMPORTANT**—The application MUST be completed and received by the early voting clerk in the Travis or Williamson County Elections Division office by April 25. NOTE: If you submit an ABBM by fax or email, it must also be submitted by mail and received in the appropriate office within four business days of your electronic submission.
- 3. Once received, the mail-in ballot MUST be completed and received by the appropriate early voting clerk no later than Election Day, May 6, or postmarked on May 6 and received by May 8, or by May 11 if mailed outside the US. NEW VBM tracker and "Cure" process available at VoteTexas.gov.
- ➤ Track your VBM application and VBM ballot throughout the election process.
- > Provide contact information on your VBM application so the county may contact you if you need to fix an error with your application or ballot.

STUDENT VOTERS

Students may use either their parents' address or their college address for voter registration, whichever they consider to be their permanent address. Students cannot be registered in both places. Those who will be away from their permanent address on Election Day and during early voting may request a ballot by mail from their county clerk's office. Student voters should also know that college or university student photo IDs are not accepted at the polls. Be aware of the general ID requirements.

VOTING SYSTEM

Both Travis and Williamson Counties are now using an Express-Vote Ballot Marking Device (BMD), which uses touch-screen technology but produces a paper ballot for tabulation. It is modern, secure, and allows you to verify your selections before casting your vote.

Steps to Vote

1. VOTE: At check-in you will receive a blank ballot. Insert this ballot into any Express-Vote BMD. Follow instructions on the screen to make your selections. Poll workers will be available if you need assistance.



2. REVIEW: When prompted, print your ballot. Carefully review all the selections printed on the card to be sure it accurately reflects your



3. SCAN: You MUST then scan your ballot into the DS200 scanner to cast your vote. Do NOT leave the polling location with your ballot.

Answers from candidates who didn't respond by the print deadline may be available online.

HOW THE LEAGUE GATHERS CANDIDATE INFORMATION

To compile the *Voters Guide* information, the League of Women Voters Austin Area sends questions to all candidates in major contested races. League members verify accurate contact information provided by various election entities and the Texas Secretary of State. The League formulates all questions through a

rigorous questions committee. Candidate replies are printed without editing or verification of content. Due to space restrictions, candidates are given strict character limits. The form into which they enter answers prohibits them from violating the limit. If a response has been cut off due to this constraint, the response has [.] inserted at the end. Candidates are also asked to avoid negative references to their opponents. We reserve the right to redact portions of responses that do not meet our guidelines. Those appearing without a photo failed to submit one. Candidates must submit answers by the deadline provided in order to be included in the printed version. Answers on VOTE411.org may be updated after the print deadline.

CANDIDATE RESPONSES

The League of Women Voters Austin Area reviews all candidate responses carefully for adherence to our guidelines. The League reserves the right to redact portions of a candidate's response, but avoids doing so as much as possible. Candidate replies are printed without editing or verification of content. The League takes First Amendment rights seriously and believes that the public has a right to know what the candidates think and what they stand for, even if it may be considered offensive. Each candidate is personally and solely responsible for the content of their response.

HOW DOES THE LEAGUE HANDLE **BALLOT MEASURES?**

For each ballot measure (such as bonds, charter amendments, or other propositions), the League researches and analyzes the topic and provides information to help explain the background and effects of the proposed change. We do not always include pros and cons, and instead focus on explaining potential effects of the measure's passing. If we do offer pros and cons, we make

sure they are balanced and include both points of view. The following information is typically included:

- Background: How did this get on the ballot and what group brought it forward?
- > Ballot language explainer: What does the ballot language re-
- > Potential effects: What possible effects will this ballot measure have on our area?

POLICE OVERSIGHT ACTS

Background

In the summer of 2022, a criminal justice political group called Equity Action gathered more than the required 20,000 valid signatures on a proposal for the Austin Police Oversight Act, which if passed would strengthen the power of the Office of Police Oversight. The Austin City Council opted to put this proposal before voters as Proposition A.

Then, a second political group called Voters for Oversight and Political Accountability, mostly funded by the Austin Police Association, gathered more than 20,000 valid signatures on a proposal that was very similar in wording to the Equity Action proposal, but would in practice limit the powers of the Office of Police Oversight. The Austin City Council opted to put this proposal before the voters as Proposition B.

PROPOSITION A

Ballot Language

Shall the voters of Austin adopt an initiated ordinance, circulated by Equity Action, that will deter police misconduct and brutality by strengthening the City's system of independent and transparent civilian police oversight?

Explanation

Both Prop A and Prop B state that the Office of Police Oversight's role is to advise the City on investigations and the effectiveness of the police department's policies and procedures. However, Prop A's provisions give the Office of Police Oversight more investigatory power. Prop A will give the Office of Police Oversight more power by allowing anonymous complaints to be submitted, and giving the Office of Police Oversight the ability to access personnel records and to conduct investigations into officer misconduct. For more information on Prop. B, see below.

Supporters of Prop A say that the current Office of Police Oversight has little authority and the passage of Prop A will empower civilian oversight of police activities. Opponents say that several of the pieces of the ordinance violate state law and, if passed, the ordinance will be overturned by the courts. If both acts pass, the matter will likely go to the courts.

PROPOSITION B

Ballot Language

Shall the voters of Austin adopt an initiated ordinance, circulated by Voters for Oversight and Police Accountability, that will strengthen the City's system of independent and transparent civilian police oversight?

Explanation

Both Prop A and Prop B state that the Office of Police Oversight's role is to advise the City on investigations and the effectiveness of the police department's policies and procedures. However, Prop A's provisions give the Office of Police Oversight more investigatory power. Prop B will do away with the ability to submit anonymous complaints and will limit the Office of Police Oversight's ability to access personnel records and to conduct investigations into officer misconduct. For more information on Prop. A, see above.

Supporters of Prop B say the proposition will incorporate civilian oversight in a way that does not conflict with state law. Opponents say the Office of Police Oversight will be left toothless and will not be allowed to receive anonymous complaints or investigate any complaints. If both acts pass, the matter will likely go to the courts.

BOND ELECTION

PROPOSITION A

Background

This proposition requests authorization to borrow money for improvements to park, recreation, and sports facilities in the City of Round Rock. The city's most recent bond package was passed in 2013 and parks and recreation projects from that bond are currently just being completed. This new package is based on longrange plans developed by the city, including the city's 2030 Comprehensive Plan, the Parks and Recreation Master Plan, and a Recreation Center Needs Assessment conducted in 2021. Citizen Surveys in 2020 and 2022 provided additional public input to guide the selection of projects included in this package.

Ballot Language

The issuance of \$230,000,000 bonds by the City of Round Rock, Texas, for city parks, recreation and sports projects, comprised of: a new recreation center building that also includes parks and recreation administration offices, an outdoor track, multipurpose athletic fields, tennis complex relocation, Lakeview Pavilion improvements, Rock'n River Water Park expansion, Clay Madsen Recreation Center remodel, Sports Center expansion, Lawn At Brushy Creek Park development, citywide trail expansion, play for all park improvements, and systemwide park improvements, and also including land acquisition, design costs, required equipment and related drainage and other related costs. Taxes sufficient to pay the principal of and interest on the bonds will be imposed.

Explanation

Proposition A, if passed, will authorize the city to borrow \$230 million for park, recreation, and sports facilities. These projects include new construction, renovations, expansions, and major maintenance of facilities throughout the city. Several of the projects focus on facilities at the city's Old Settlers Park, including construction of a new recreation center (which will also include Parks and Recreation Department offices), expansion of the Rock'N River water park, extensive remodeling of the Lakeview Pavilion, and an expansion of the Multipurpose Sports Complex (which would include a complete relocation of the tennis complex). Projects in other parts of the city include citywide trail expansion, upgrades for the Play for All Park, establishment of a new park (The Lawn at Brushy Creek in downtown Round Rock), a remodeling project for the existing Clay Madsen Recreation Center, an expansion of the Round Rock Sports Center, and systemwide infrastructure upgrades to provide improved lighting, irrigation, and shade awnings for city parks.

The tax impact estimates that the city has provided show how

property owners' taxes will be affected if both Proposition A and Proposition B are passed. This estimate would include changes in the debt rate and the maintenance and operations rate. According to these estimates, the property tax rate would increase \$0.069 over the next five to seven years. This would mean that a homeowner with a home worth the median home value in the city could expect an increase of \$3-\$4 in monthly property taxes.

PROPOSITION B

Background

This proposition requests authorization for public safety facility improvements. The city's most recent bond package was passed in 2013 and public safety projects from that bond included the initial construction of the City's Public Safety Training Center (completed in 2018) and the construction of 3 new fire stations. Some project features were cut from the 2013 project plan. This proposition proposes completing the initially envisioned features and adding new construction projects.

Ballot Language

The issuance of \$44,000,000 bonds by the City of Round Rock, Texas, for city public safety projects, comprised of: improving

the city's public safety training center, relocation of the central fire station and two new fire stations, and also including land acquisition, design costs, required equipment and related drainage and other related costs. Taxes sufficient to pay the principal of and interest on the bonds will be imposed.

Explanation

Proposition B, if passed, will authorize the city to borrow \$44 million for new construction and expansion of public safety facilities in the city. One of the projects would be the expansion of the Public Safety Training Facility to include features (a highspeed driver training track and expanded classrooms) that were cut from the original plans included in the 2013 proposal. Other projects include the relocation of the city's Central Fire Station and the construction of two additional fire stations, to be located in the northern part of the city.

The tax impact estimates that the city has provided show how property owners' taxes will be affected if both Proposition A and Proposition B are passed. This estimate would include changes in the debt rate and the maintenance and operations rate. According to these estimates, the property tax rate would increase \$0.069 over the next five to seven years. This would mean that a homeowner with a home worth the median home value in the city could expect an increase of \$3-\$4 in monthly property taxes.

BOND ELECTION

BACKGROUND

In the summer of 2022, Eanes ISD established a bond advisory committee made up of 12 members who reviewed different categories of need for the district, including safety and security, energy efficiency and conservation, facilities, and student programs and support over a series of six public meetings. The bond advisory committee recommended a \$131.429 million bond package. The board of trustees voted to call an election with three separate propositions based on the committee's recommendation.

None of the propositions are projected to raise the school dis-

EANES ISD

trict's property tax rate; the debt service tax rate will remain \$.12 per \$11 property valuation regardless of the election's outcome. New taxable growth (such as new neighborhoods and commercial developments) and increasing property values in Eanes ISD are projected to cover the cost.

PROPOSITION A

Ballot Language

The issuance of \$117,773,000 bonds for the construction, acquisition, rehabilitation, renovation, expansion, improvement and equipment of school buildings in the District, including (i) safety and cybersecurity improvements, (ii) student programs and support, (iii) instructional and co-curricular spaces, (iv) promotion of energy efficiency and conservation, (v) facility systems and site improvements throughout the District (including plumbing, roofing, heating, ventilation, air conditioning, flooring and other systems), and (vi) the purchase of new school buses, and the levying of a tax to pay the bonds and any related credit agreements. This is a property tax increase.

Explanation

Proposition A, if passed, will cost 117.773 million dollars and will include safety and security upgrades, physical repairs, and refurbishments at every campus (including energy-efficiency projects, network replacements, new learning management systems, library modernization, and more).

PROPOSITION B

Ballot Language

The issuance of \$2,411,000 bonds for the equipment and improvement of the Eanes ISD Stadium including safety, accessibility, lighting, and other integral components, and the levying of a tax to pay the bonds and any related credit agreements. This is a property tax increase.

Explanation

Proposition B, if passed, will cost 2.411 million dollars to refurbish Chaparral Stadium, including pole lighting replacements, track surface replacement, bleachers, handrails, and video board replacement.

PROPOSITION C

Ballot Language

The issuance of \$11,245,000 bonds for the acquisition, installation and update of instructional technology equipment for students and staff in the District, and the levying of a tax to pay the bonds and any related credit agreements. This is a property tax increase.

Explanation

Proposition C, if passed, will cost 11.245 million dollars to replace student and staff digital devices, as well as devices in labs, classrooms, and offices.

BOND ELECTION

Background

Recognizing that recent rapid growth in the Hutto area would soon challenge Hutto ISD's existing facility capacity, the school district formed a Long Range Facilities Planning Committee in August 2022. Members of the committee included parents, students, district staff members, and community members. The committee met over the course of several months, and in December 2022 issued a prioritized list of projects the committee recommended to meet the district's facilities needs. The Hutto ISD school board voted on January 26, 2023 to call a bond election to be held on May 6, 2023, and to present three of five drafted propositions to the voters.

The district is required by law to include the phrase "This is a property tax increase" in the language of bond propositions. However, because of the increased size and value of the tax base in the district, the tax *rate* will not increase to fund these bonds. The district has been able to decrease the tax rate in seven of the past eight years.

PROPOSITION A

Ballot Language

The issuance of \$471,500,000 of bonds by the Hutto Independent School District for school facilities (including two new elementary schools, build-out of the 9th grade center, renovations to existing high school, additions to the existing middle schools,

career and technical education facilities, and technology infrastructure and upgrades), the purchase of the necessary sites for school facilities, and the purchase of new school buses and the levying of a tax in payment thereof and the cost of any credit agreements. This is a property tax increase.

Explanation

If passed, the projects in Proposition A will cost a total of \$471.5 million and will fall into two categories: 1) growth and 2) renovation, upgrades, and maintenance.

Growth: This category of projects includes the construction of two new elementary schools, classroom wing additions to the district's two middle schools, the build-out of the existing 9th Grade Center into the district's second comprehensive high school, and land acquisition to accommodate school sites needed for future growth.

Renovation, Upgrades, and Maintenance: This category of projects includes finishing already initiated renovation projects at Hutto High School, including new facilities for programs in Fine Arts, Career and Technology, and Athletics; replacement of outdated plumbing, electrical, and HVAC systems; replacement of outdated school buses and construction of a second operations station; and technology infrastructure upgrades to improve connectivity, data storage, and security.

Ballot Language

The issuance of \$10,500,000 of bonds by the Hutto Independent School District for instructional technology and the levying of a tax in payment thereof and the cost of any credit agreements. This is a property tax increase.

Explanation

If passed, Proposition B will cost a total of \$10.5 million. This proposition would provide funding for the purchase of student and faculty one-to-one instructional technology devices, both to replace aging equipment and to provide for growth in the number of devices required.

Ballot Language


The issuance of \$40,000,000 of bonds by the Hutto Independent School District for school facilities (including renovations and additions to the district's academic center), and the purchase of the necessary sites for school facilities, and the levying of a tax in payment thereof and the cost of any credit agreements. This is a property tax increase.

Explanation

If passed, the projects in Proposition C will cost a total of \$40 million. This proposition would provide permanent facilities at the Hutto ISD Academic Center on College Street for the district's Disciplinary Alternative Education Program (DAEP), for the River Horse Academy (which provides flexible alternative high school education programs), and for the district's Special Education 18+ Program.

LEANDER ISD

BOND ELECTION

Background

During the fall of 2022, Leander ISD convened a 150-member committee to study the needs of all of the district campuses, with a focus on student learning, security coverage and technology capabilities. The recommendations were then presented to a steering committee, which brought forward a final bond proposal to the Leander ISD Board of Trustees. After careful review, the Board approved a bond total of \$762.8 million, addressing security, ongoing maintenance, optimal utilization of current facilities, modernization and repairs at every high school, the design of a new middle school and the construction of two new elementary schools.

As a result of conservative fiscal management, enrollment growth, and retiring of old debt, Leander ISD will not raise the tax rate in order to pay for these bonds. The interest and sinking portion of the district's property tax rate, which pays for bond debt, will stay at \$.33 per \$100 of assessed property value.

PROPOSITION A

Ballot Language

The issuance of \$698.3 million of bonds by the Leander Independent School District for school facilities, the purchase of necessary sites for school facilities, buses and vehicles and the imposition of a tax sufficient to pay the principal of and interest on the bonds and the cost of any credit agreements. This is a property tax increase.

Explanation

Proposition A, if passed, permits the Leander ISD to issue and sell bonds in a principal amount not to exceed \$698.3 million for all aspects of building new or renovating existing school facilities (including any necessary purchases of sites and/or removal of existing school facilities), the purchase of new or retrofitting of existing school buses, and the purchase of new or retrofitting vehicles used for emergency, safety, or security purposes.

PROPOSITION B

Ballot Language

The issuance of \$50.8 million of bonds by the Leander Independent School District for technology equipment and technology infrastructure and the imposition of a tax sufficient to pay the principal of and interest on the bonds and the cost of any credit agreements. This is a property tax increase.

Explanation

Proposition B, if passed, would permit the Leander ISD to issue and sell bonds in a principal amount not to exceed \$50.8 million for the purpose of acquiring and upgrading technology equipment and technology infrastructure.

PROPOSITION C

Ballot Language

The issuance of \$13.6 million of bonds by the Leander Independent School District for renovations to performing arts centers and the imposition of a tax sufficient to pay the principal of and interest on the bonds and the cost of any credit agreements. This is a property tax increase.

Explanation

If passed, Proposition C permits the Leander ISD to issue and sell bonds in a principal amount not to exceed \$13.6 million for renovations and new equipment for the Don Tew Performing Arts Center and the South Performing Arts Center.

BOND ELECTION

Background

The 2022-23 Long-Range Planning Committee for the Liberty Hill ISD Board of Trustees, composed of parents, teachers, students, community members, and support staff, studied the needs of the district over the course of many meetings. They focused on the district's rapid growth and the need to ensure safety, security, and the ability to continue to expand programs. In early 2023, the committee recommended and the Liberty Hill ISD Board of Trustees unanimously approved an order calling for a \$471.1 million bond election to take place on May 6, 2023. The bond proposal is made up of three propositions.

The Liberty Hill ISD Board of Trustees projects that this bond proposition will not result in a property tax rate increase.

PROPOSITION A

Ballot Language

The issuance of \$459,000,000 of bonds by the Liberty Hill Independent School District for school facilities (including districtwide safety and security, fine arts facilities related to fine arts education, and career and technical education (CTE) facilities) and the levying of a tax in payment thereof. This is a property tax increase.

Explanation

If passed, Proposition A would permit the Liberty Hill ISD to issue and sell bonds in the principal amount of no more than \$459 million for school facilities, district-wide safety and security, expansions related to fine arts education, academics, and enrichment programing, and career and technical education (CTE) facilities.

The District has plans for constructing an additional high school as well as two elementary schools (numbers 8 and 9). A portion of the funds will also support design and site development for a 10th elementary school, as well as construction of a new transportation building and additional maintenance and warehouse buildings to accommodate growth.

In the area of academics/fine arts/enrichment, the district plans to expand the existing high school band hall, choir room, robotics workshop, cafeteria, and other instructional spaces. Additional funds will be used to replace all field turf used for physical education and other instructional purposes, and to renovate existing space for several programs, including 18+ Program, Success Academy, and Disciplinary Alternative Education Program. In addition, the district will replace outdated CTE (Career and Technical Education) equipment and purchase audio-visual equipment.

For purposes of ensuring safety and security, the district seeks to invest in security measures that include: secure vestibules, cell phone boosters, security cameras, fencing, radios, an alert system, and blinds.

Proposition A will also fund major maintenance projects including: roofing, HVAC upgrades, and other replacement and maintenance repair needs. The district also seeks to upgrade

technology in the area of network and fiber infrastructure, wiring, access controls, and WAPS (Wireless Access Points).

Finally, the District wishes to expend a portion of bond funds for new land acquisition for future sites as well as for an infrastructure allowance.

PROPOSITION B

Ballot Language

The issuance of \$7,100,000 of bonds by the Liberty Hill Independent School District for school technology and the levying of a tax in payment thereof. This is a property tax increase.

Explanation

The Liberty Hill High School Technology Department has been working on standardization of student and staff technological equipment. Proposition B supports a continuation of the department's "technology refresh plan" that is on a 5-year cycle. If passed, Proposition B will permit the Liberty Hill ISD to issue and sell bonds in a principal amount not to exceed \$7.1 million for laptops, tablets, software, and other technology devices for students and staff.

PROPOSITION C

Ballot Language

The issuance of \$5,000,000 of bonds by The Liberty Hill Independent School District for school stadium facilities and the levying of a tax in payment thereof. This is a property tax increase.

Explanation

Proposition C, if passed, would provide for \$5 million to renovate certain stadium facilities at Liberty Hill High School, including an additional concession stand/restroom, and turf replacement for Panther Stadium Field.

Panther Stadium at Liberty Hill High School is used by a number of athletic and fine arts student groups including football, track, soccer, band, drill team, cheer, and more. The construction of an additional concession stand and restrooms will accommodate the growing number of students and spectators who attend various athletic, extracurricular, and UIL competitions.

Teacher Retention: Both are important for the growth and success of the district. Some ways to do this are to be competitive in pay and compensation, look at ways to reduce teacher workloads, foster collaboration, and open communication, have a positive work culture, encourage a culture of listening, increase support services, build a cohesive team, and have a good work environment.

Student Outcomes: I will continue to analyze the data within the district in support of solutions to make informed decisions. We cannot implement a one-size-fits-all solution. I will hold the Superintendent accountable for implementing techniques, tools, and resources to address academic, social, and emotional outcomes for all students. It is critical to consistently review these to ensure the goals are met.

Libraries: The Texas State Library and Archives Commission, in consultation with the SBOE, adopt standards for school library services (TEC § 33.021). Local policy (EF Legal) provides additional guidelines regarding school libraries. I will ensure the superintendent implements and monitors our libraries' plans, procedures, programs, and systems.

School Safety: Increase state funding specifically for safety and security. Provide more tools, and resources for safety programs, students, and staff. Continue using behavioral threat assessment and management. This helps identify a threat, intervene with appropriate resources, and ultimately improve the safety and wellbeing of the individual of concern, the situation, and the school.


